A. Authorizing Application for Missouri Highway and Transportation Commission American Rescue Plan Act (ARPA) Grant

Commissioner O'Neill made a motion that the Board of Commissioners adopt a Resolution Authorizing Port KC to apply for grant funding from the Missouri Highway and Transportation Commission.

A. Resolution Inducing the Issuance of Bonds – Project Sand

Commissioner Terrebonne made a motion that the Board of Commissioners adopt a Resolution expressing Port KC's intent to issue its bonds (Project Sand), in multiple series, in an amount not to collectively exceed \$243,705,000.
